## Assignment of Space & Payment

All exhibit space will be allocated on a first-come, first-served basis. Confirmation of space will be sent immediately upon receipt of a signed contract and full payment. All advertising materials, company listing information and contracts for exhibit space must be submitted/acknowledged by June 15, 2025. The Florida Association of Medical Examiners (FAME) reserves the right to re-assign table space if necessary. Payment in full is due within 30 days of the contract submission if requesting check submission. Exhibition table assignment will be released if payment is not received within 30 days. No exhibitors shall assign, sublet, or share the whole, or any part, of the space contracted with any other company without prior written consent from FAME. All exhibit requests are due by June 30, 2025.

## Exhibition Space Specifications

The standard booth configuration is 10'x10' and includes an 8' table and two chairs. Additional furnishings, electrical and internet services are available and must be purchased directly from Destin-Fort Walton Beach Convention Center exhibitor portal.

## Additional Exhibitor Tickets and Name Badges

Additional tickets and event badges are available to purchase for exhibiting companies at the price of an individual attendee registrant. Breakfast and Breaks during the conference are available to exhibitors. Lunches, receptions and dinners are not included unless specified with select sponsorship levels.

## Setup & Breakdown of Exhibits

The setup of exhibits may begin on Wednesday, September 10, 2025 at 8:00 a.m. All exhibitors must be fully assembled and ready for display no later than 12:00 p.m. on September 10. Breakdown of exhibits may begin after 1:00 p.m. on Friday, September 12, 2025. All exhibits and materials must be totally removed from the exhibit hall no later than 6:00 p.m. on Friday, September 12, 2025.

## Cancellation

Exhibitors may reduce or cancel contracted space by submitting written notice to Dan Schebler at [dans@d1meo.org](mailto:dans@d1meo.org). Such notice must be received and acknowledged by FAME no later than June 30, 2025. Exhibitors cancelling an entire exhibit space before June 15 shall be charged an administrative fee of 25 percent of the total cost of display space. Considerations for cancellations made after June 30 will be made resulting in the assessment of an administrative fee of 50 percent of the total cost of display space. No refunds will be made if written notice of cancellation or reduction is not received by August 15, 2025.

## Restrictions

FAME reserves the right to determine the eligibility of a company or their product for inclusion in the exhibits, and reserves the right to restrict exhibits that, because of noise, method of operation, materials or for any other reason, become objectionable to FAME. FAME also reserves the right to prohibit any exhibit that, in the opinion of FAME management, may detract from the general character of the exhibit show as a whole. FAME reserves the right to prohibit any exhibit where the exhibiting company's products and services do not directly relate to the medicolegal industry. In such an event, any exhibitor terminated prior to expiration of the symposium for cause shall not be entitled to a refund or be entitled to damages for any direct or indirect expenses incurred by the exhibitor. The exhibition of a company's products or services within the FAME Exhibit Hall does not represent an endorsement of those products or services by FAME. No signs will be affixed by any means to the walls, doors or any other surface in the exhibit area. FAME policy firmly restricts representation of an organization that has not been assigned an official exhibit table from soliciting business and/or distributing promotional material of any type within the exhibit area or any other areas assigned to FAME by the DFWCC. Further, those organizations that have been assigned an official FAME exhibit table must conduct all business activities from within their assigned table space and may not impede traffic through the Exhibit Hall aisles and other areas. No one is permitted into the Exhibit Hall during installation times except for authorized personnel (those with Exhibitor Badges) who are working or supervising the installation of tables, equipment, or furnishings. Absolutely no children under the age of sixteen (16) will be admitted in the exhibit hall during installation or break down under any circumstances.

## Liability

In consideration for the opportunity to display services and products as an Exhibitor at the FAME Annual Training Conference, the Exhibitor's officers, directors, agents and insurers, agree to indemnify and hold harmless FAME and its directors, contractors, employees, and agents, and Destin Fort Walton Beach Convention Center (DFWCC) venue from any loss, injury, suit, action or cause of action, or claim whatsoever resulting from any incident, accident, fire, theft or any claim or loss to any person claiming loss or injury, including any loss or damage to property of the Exhibitor, its employees, agents or subcontractors, loss or injury to any manufacturer's demonstration participants, their employees, agents, guests and general public. Said indemnification and agreement to hold harmless FAME and the DFWCC, as aforesaid, shall include reimbursement for any costs, expenses and reasonable attorney's fees incurred by indemnities. Further, any claim of damage to the property of the DFWCC resulting in the immediate assessment of damages against FAME from any act or omission of the Exhibitor, its agents, employees, contractors and subcontractors, shall be immediately paid or assumed by the Exhibitor. In addition, the Exhibitor acknowledges that FAME does not maintain any insurance to cover loss or damage to any property of the Exhibitor. Exhibitors are advised to obtain commercial insurance to cover all losses and claims.

## Security of Personal Property

Exhibitors are strongly encouraged to insure their exhibits, promotional items, display materials, and any other items against theft, fire, etc. at their own expense. No separate security will be provided by FAME; however, doors will be locked overnight.
